
TERMS AND CONDITIONS

A. General Information

- Admission is by registration only.
- For safety reasons, infant, toddlers and any minors below the age of **16** are strictly not allowed in the Event.
- Entry into the Event is subject to full payment being received by the Organiser prior to its commencement.
- The Organiser reserves the right to refuse acceptance of any registration without prejudice.
- All attendees have to be in **business attire**. The Organisers reserve the right to refuse entry to those deemed inappropriately dressed.
- All passes are non-transferable and have to be worn at all times. All participants are advised to bring along personal identification as security checks may be carried out at the Organisers' discretion.

B. Registration Periods and Fees

- All fees payable are in **Singapore Dollars** and are subject to a 7% Goods and Services Tax (GST)
- Promotional codes and / or discounts cannot be accrued and can only be used once.
- Early Bird Rate Registration Period: Early Bird Rate will be applicable till 16 August 2019, 23.59 hrs, Singapore Time. For registrations received thereafter, Regular rate will apply. In order to qualify for this rate, payment must be received on or before 16 August 2019.
- Regular Rate Registration Period: Regular Rate will be applicable till 10 November 2019, 23.59 hrs, Singapore Time. For registrations received thereafter, Regular rate will apply. In order to qualify for this rate, payment must be received on or before 10 November 2019.
- Onsite Rate Registration Period: Onsite Rate will be applicable from 11 November 2019, 00:00 hrs, Singapore Time till end of event.
- Registration for the Event is only confirmed upon receipt of payment.
- Payment should preferably be made online by credit card (AMEX, MasterCard or Visa) during the registration process. Payment by bank transfer is only available till 4 October 2019.

C. Cancellation & Substitution Policy

- Downgrading of registration will not accepted. Attendees may nominate another person from their organisation (at no additional cost) to attend on their behalf up to two (2) weeks prior to the start of the event. Notice of substitution must be given in writing up to two weeks prior to the start of the Event to the Organiser at fintech.reg@singex.com. Failure to do so may result in the replacement being barred from entering the Event. No refund of the registration fee will be made for cancellations without substitution, or for "non-attendance".

D. Payment of Registration Fees

- Registration for the Event is only confirmed upon receipt of payment. Once payment has been received, an email confirmation will be sent. If payment is not made at the time of booking, registration will be provisional. Bookings received made than two weeks before the Event date must be paid by credit card.
- Please note that payment made via credit cards issued by non-Singapore issuing banks may be subjected to a currency conversion surcharge imposed by the respective credit card issuing bank. Please contact your bank to enquire on the applicable rates and charges.

E. Visa Requirements/Invitation Letter

- It is the sole responsibility of the attendee to take care of visa requirements. Attendees who require an entry visa must allow sufficient time for the visa application procedure. Attendee registration details might be shared with the immigration authorities to assist in the immigration process. However, the Organiser will not contact embassies and consulates on behalf of visa applicants.
- To receive an invitation letter for the Event, attendees must first register and pay the registration fees in full. After that, attendees can send a request for an invitation letter to fintech.reg@singex.com.

F. Alterations to Programme – Cancellation/Postponement of Event

- The Organiser reserves the right to make alterations to the programme, venue, dates, and timings of the Event at any time and/or to cancel the whole or any part of the Event.
